Upon consideration of the Report of Hearing Master Pursuant to C.R.C.P. 236(a) filed in the above cause, and now being sufficiently advised in the premises,


IT IS ORDERED that said Report of Hearing Master shall be, and the same hereby is, APPROVED.

<p>REPORT OF HEARING MASTER PURSUANT TO C.R.C.P. 236(a)</p>	

This matter is before the Presiding Disciplinary Judge ("PDJ") on an "Order Appointing Hearing Master" issued by the Colorado Supreme Court ("Supreme Court") on December 8, 2010. In its order, the Supreme Court enjoined Debra Jazwinski ("Respondent") from the unauthorized practice of law and referred the matter to the PDJ "for findings and recommendations concerning the amount of restitution, fines, and costs" against Respondent.

On December 9, 2010, this Court issued an "Order of Hearing Master Pursuant to C.R.C.P. 234-236," directing the People to file a motion detailing their requested recommendations with supporting documentation on or before February 7, 2011, and Respondent to file her response to the People's motion within fifteen (15) days of the filing date of the motion. On February 2, 2010, Kim E. Ikeler, Office of Attorney Regulation Counsel ("the People"), filed "Petitioner's Request for Restitution, Fines and Costs" and supporting documentation. Respondent did not file a response.

In their request, the People ask for restitution in the amount of \$500.00, representing the amount of legal fees Respondent received for her "legal services." The People request that this money be refunded to Dennis Calcaterra. The People also ask the minimum fine of \$250.00 be assessed against Respondent, contending that this was Respondent's first offense and that the harm was not great. In addition, the People attach to their motion a "Statement of Costs" in the amount of \$91.00 for their administrative fee.

The PDJ concludes that under the circumstances, the established facts support an imposition of the minimum allowable fine of \$250.00. Accordingly, the PDJ **RECOMMENDS** that the Supreme Court order Respondent to pay
